EXHIBIT SET UP: Please be setup15 minutes before attendees arrive. Setup starts 6:30 am on Saturday June 22, Booth spaces are 10'X10' outdoor only.

This is an outdoor only event. Outdoor tents must be secured with weights and tied down in case of high winds. If your tent causes damage, you will be held responsible for damages and/or injuries. Lets have safe event please secure your tent. Thank you.

PARKING INSTRUCTIONS: After unloading to your booth please park your vehicles behind the Madden hall building, in the designated parking areas. Please remove valuables and lock your cars. The Solano County Home & Garden Show and Dixon Fairgrounds are not responsible for damaged, lost or stolen vehicles.

- NO vehicles are to be in front of the gates, fire entrances and/or exits, and emergency roads during our event, you need to park in designated exhibitors parking.
